## **Aviation Lighting**

- LA provided members with the feedback received from the National Wind Farm Commissioner, Andrew Dyer following the meeting convened by him and held on 11/4/19 with stakeholders (CASA, Air Services Australia, CEC, NSW DP&E, Planning Victoria, etc).
- PM provided members with the feedback received from Anna Freeman from the Clean Energy Council, who attended the same meeting and commented that she was buoyant about the discussions held.
- CASA will work on revising the guidelines (National Airports
   Safeguarding Framework Principles and Guidelines) Guideline D Guideline D: Managing the Risk of Wind Turbine Farms as Physical
   Obstacles to Air Navigation. Link to current guidelines:

- It is expected that the review will take up to 12 months.
- Discussions ensued between attendees who were all in agreement that the community were united in its view that there should be NO lights turned on at night.
- Whilst the lights at the reduced illumination of 10% is an improvement, all feedback received at the CCC to date is consistent that the community are opposed to any lighting being seen. Clearly the community don't want them turned down they want them off
- It was recommended that a modification application be lodged to remove the condition of consent requiring lighting, however, CWP will await CASA's review of the guidelines, which may provide a more consistent approach across all wind farm projects.
- CS advised that she will discuss with GIS Council's General Manager, the possibility of putting a motion to the Australian Local Government National General Assembly Conference in June 2019, to lobby for a consistent national approach to aviation lighting.

Minutes from meeting to be distributed to CCC when received from NWFC.

It remains the position of this CCC, who represent the community impacted by the aviation lighting, that the lights be turned off permanently.

# 7.0 Project Presentation

PM advised that:

- The project is fully operational.
- Routine maintenance is occurring in accordance with procedures.
- A circuit breaker tripped in one of the turbines, which is being repaired at the moment.
- Noise monitoring is currently occurring with 12 monitors being positioned in approved locations (close to residences, turbines, boundaries, etc). Weather stations are also attached to the monitors to record this information, which is taken into account when assessing the results.
- When the results are available, a summary will be provided to the CCC.
- Monthly surveys are undertaken in accordance with the Bird & Bat Management Plan, with 4 fatalities being recorded.

PM to provide noise monitoring results to next CCC.

BS provided some background information concerning noise levels associated with the operation of turbines on his property.

#### 8.0 General Business

- BS advised that a meeting was held recently concerning the assessment of applications for funding under the Sapphire Wind Fund Community Fund program, where it was decided to divide into two bundles – Summer & Winter. With \$180k available per annum, \$90k will be considered in each half.
- The first round of applications totalled \$300k from 40 groups, which required detailed consideration.
- Those groups that were unsuccessful in this round of funding will be provided with feedback and invited to re-apply.
- As a Section 355 committee, with a membership of five, Inverell Shire Council are supporting the process.
- CS advised that there is \$5k in the GISC community fund, which will be available for applications received at the same time.
- CS commented that she has received positive feedback from residents and businesses regarding wind farms in the region.
- NE requested an update on the Sundown Solar Farm. PM advised that the project is still at EIS stage. One of the issues being investigated is the use of tracking solar panels.
- PM advised that the cut-off period for the Community Co-Investment Program has been extended to 30/6/19 and is now open to all in NSW & ACT.
- BS enquired how many employees will be needed to build the Sundown Solar Farm. PM advised that approximately 200 people during construction and 4-5 permanent staff when complete.
- CS stated that 72\* new permanent residents are now located in the region as a result of the renewable energy projects, with workers purchasing homes in Glen Inness & Inverell contributing to the community.
- NE informed the CCC of hydrogenation plants in Norway (NEL) and how this technology can be used to replace diesel, as an alternative to batteries used in gas fired power generators, etc. The gas can be transported by road tankers to storage depots. Noting that the northern tablelands would be a good location for businesses to take advantage of this new expertise, which could also provide more jobs. He hoped that CWP directors would consider contact with NEL.
- NE formally requested that CWP provide ongoing advice to this CCC on the progress of the Sundown Solar Farm. CS supported this request.

\*Note: CS originally stated 57 residents in the meeting, however, on checking, came back with a revised number of 72.

NE to provide information to LA for distribution to CCC.

Agreed by the CCC & CWP that updates would be provided at future meetings on the Sundown Solar Farm project.

## 9.0 Next Meeting

It was agreed to hold the next CCC as scheduled and review the frequency of the meetings on 16/7/19. LA suggested moving from quarterly to bi-annual meetings following the resolution of the aviation issue.
