## 5.0 Project Update

Ed Mounsey presented a Project Update, including:

- Outlining a proposed modification to the Project, including:
  - o A reduction in turbine numbers from 159 to 109
  - Consolidation on two layout options into a single layout
  - An increase in blade tip height from 157m to 200m
- Information about the TransGrid Renewables Hub, which would increase the amount of electricity that could be fed into the grid at the point of connection within the Sapphire Wind Farm and
- CWPR's move into solar in the area to complement the wind farm

A summary of the change in visual impact was provided, including a Zone of Visual Influence map, a comparative photomontage and a shadow flicker analysis.

It is expected the planning modification application will be lodged early to mid February and consultation will be undertaken now (prior to submission) and once the modification is submitted.
