7.0 Project Presentation

- <u>Aviation lighting</u> PM provided members with an update on negotiations concerning the lighting, including meetings with local politicians and discussions with CASA.
- PM explained the Vestas Intellight system, which is able to be retrofitted to the existing project at a cost of \$1.5-\$2M. Unfortunately, the funds were not budgeted for and none are available.
- CWP will formally request CASA to review the requirement for Aviation Hazard Lights as outlined in Condition of Approval C29A this week.
 During the Development Application phase the independent aviation consultant advised that that the lights were not needed. Whilst CASA acknowledges that the lights are obtrusive and offensive, it insists that the turbines will create a risk if they are not light.
- PM explained CASA's reliance of the previously planned flight school for Glen Innes and their requirements for visual distances. The Flight

PM to keep CCC informed of the progress of this important issue.

It was suggested that funds from the CBF be used to finance the installation of Intelilight system as this would benefit the community.

- School formally withdrew its Development Application in late December 2017.
- PM advised of the recent approval of a wind farm in Victoria, which
 requires the installation of the radar lights. It is anticipated that all
 new wind farm projects may have to adopt this system.
- A meeting will be held with representatives from the Department of Planning & Environment, CASA and CWP on Friday 6 July to try and progress the issue.
- PM advised that there had only been 13 formal complaints received about the lights of which 3 are follow up complaints. Further discussion ensued and it was recommended that every person lodge a complaint via the Sapphire Wind Farm portal on-line system.
- AS enquired whether the lighting issue had been included in the neighbourhood agreements. PM responded that the agreements were confidential, however, the EIS for the project, did state that lights would be installed if required by the approval.
- PM advised the committee that the Community Benefit Fund has been established and will meet to discuss its charter. It is likely that Glen Innes Severn Council will not create a separate CBF, rather combine its interest with Inverell Shire Council's CBF 355 Committee.
- AS asked if CWP have provided money into the fund. PM stated that once the turbines were operational, the contributions would commence.
- PS informed the CCC about the state government's Stronger Country Communities Fund, which has grants available for regional growth projects.
- PM informed members about activities on the site. Of the 75 turbines;
 43 towers have been commissioned, 28 towers are available to produce power.
- Currently, testing is being conducted to demonstrate to the Australian Market Operators that the towers won't cause any disruption to the existing system.
- Temporary Met Masts will come down in the next few weeks.
- Consideration of a third crane coming to the site to increase productivity as the project is behind due to weather impacts. Work will now be 24/7 on 12 hour shifts – 6 to 6. This has been approved by DP&E.
- All components are in the country and the current completion date is expected for mid-September 2018.
- NE enquired about the damaged blade. PM confirmed that it would be placed in a shipping container and returned to China.
- Noise surveys will be carried out within 3 months of operation.

8.0 General Business

- NE asked if anyone from Clean Energy Council would be attending the Open Day. PM advised that there were a number of events occurring around the country on that day (21/10/18), so it was unlikely that their resources would stretch to all events.
- PM advised that the Sapphire Solar is in the final stages of development consent. Just sorting out native vegetation issues and geotechnical surveys. There were 9 submissions received.

LA will contact CV (Danthonia) to advise

AS was of the opinion that EM advised in February 2018, that money had already been paid.
